

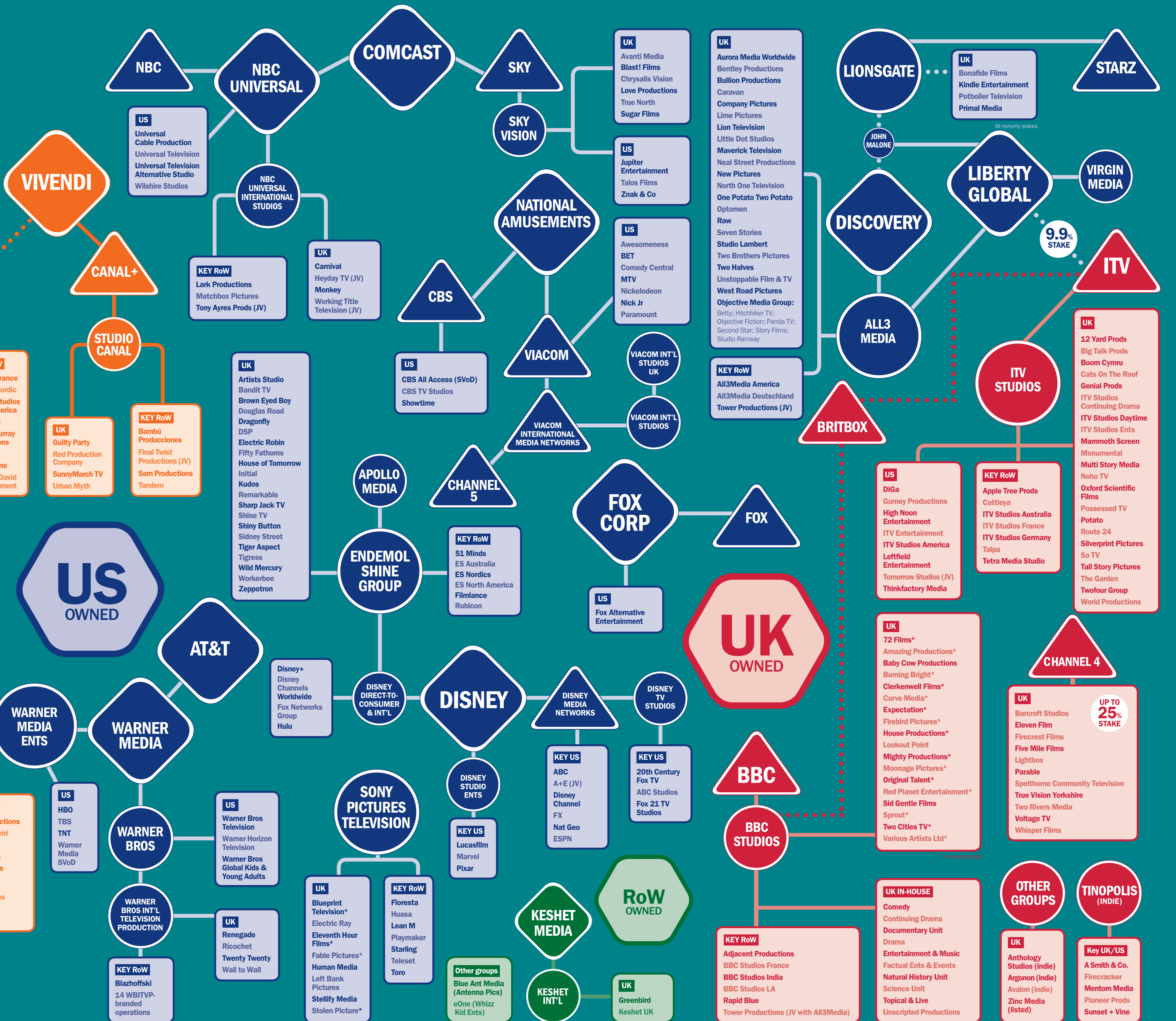

THE SHAPE OF THE CONSOLIDATED WORLD

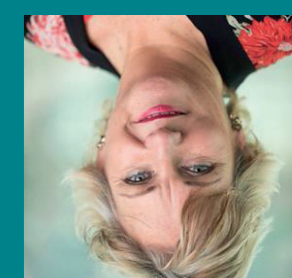
